On the strengthening of prophylaxis measures  
on new type Coronavirus infection  
(COVID-19)

Based on the decision of the Board of Directors no. 6/1 of 09.03.2020, in relation to the epidemiological situation of the new type Coronavirus infection (COVID-19), in order to ensure the health and life safety of the beneficiaries of studies and of the University employees,

### ORDER:

1. To set up the University level epidemiological commission in the following composition:

2. To ensure the continuing monitoring of the epidemiological situation and take the necessary measures. Responsible: University level epidemiological commission.
3. To comply strictly with the provisions of Order no. 41-A of 27.02.2020 On the prophylaxis measures of the new type Coronavirus infection (COVID-19);
4. To organize and carry out the academic process in classrooms or on online platforms by excluding the contact of the students with the hospitalized patients in healthcare institutions and using the interactive teaching methods: discussing the theoretical material and the clinical cases according to the study program, demonstrating the films , solving tests etc. Responsible: heads of departments and other university subdivisions.
5. To inform students daily about the epidemiological situation and the measures taken by the authorities to prevent the spread of COVID-19 infection at country level, through the University Management Information System. Responsible: deans of faculties.
6. To start daily the academic process by informing students and residents about the current epidemiological situation. Responsible: heads of departments and other university subdivisions.
7. To monitor and identify students who manifest symptoms of respiratory disorders with the recommendation to seek immediate medical attention from the family doctor and not to attend the hours until recovery. Responsible: heads of departments and teaching staff.
8. To reduce the duration of the study program by dividing it into two shifts with the following program: first shift: 8.00-11.30, second shift: 12.30-16.00. Responsible: Silvia Stratulat, head of Department of Didactics and Academic Management.
9. To open a provisional medical unit inside the Traditional Chinese Medicine Center for the triage and to provide the necessary medical assistance to the suspects / patients among the students and employees of the University (as the case may be), informing the students about the contact details and the work program. Responsible: Valeriu Revenco, vice-rector for clinical activity and residency; Angela Tomacinschi, head physician, PHI University Clinic for Primary Health Care of Nicolae Testemitanu SUMPh; head of unit of Students / residents healthcare of Nicolae Testemitanu SUMPh; Gh. Curocichin, head of Family Medicine Department.
10. People with symptoms of acute respiratory infection, returned from regions with new type Coronavirus outbreaks, or who have been in contact with a person suffering from COVID-19, are considered as "people suspected of COVID-19 infection" and:
  - 10.1 will be isolated from others;
  - 10.2 service 112 will be called to transport them to specialized hospital institution;
  - 10.3 the sample for COVID-19 will be taken;
  - 10.4 they will be isolated in the conditions of the specialized hospital, until the diagnosis is made.
11. To ensure the dissemination of information and informative materials, exclusively, from official sources, regarding the measures of prophylaxis of the infection with new type coronavirus to the University employees, through institutional personalized e-mail addresses, placing informative materials on the university portal and sharing on social

- media networks. Responsible: Silvia Ciubrei, head of the Department of Communication and Public Relations.
12. To redirect the representatives of the media institutions, that come with requests regarding the exposure on this subject, to the National Communication Group, of the Ministry of Labor Health and Social Protection. Responsible: Silvia Ciubrei, head of the Department of Communication and Public Relations, administrative, teaching and scientific staff.
  13. To inform the university community of the provisions of this order (responsible: Silvia Ciubrei, head of the Department of Communication and Public Relations) and in the meetings organized in subdivisions, against signature, with the notes in the minutes (responsible: the deans of the faculties and the heads of university subdivisions).
  14. I control the execution of this order.
